



Frequently Asked Questions

- Q. *What is the Bark 'N Bubbles Franchise Opportunity?***

A. Bark 'N Bubbles Franchise, LLC provides a professional franchise system which offers services for dogs and their owners. Services include: self service dog wash facilities (You Wash or We Wash), professional grooming, training, charity dog washes, dog birthday parties, social activities and retail pet items for sale.

We offer 2 types of franchises: our Bark 'N Bubbles franchise and our Bark 'N Bubbles franchise with "Social Puppy Pad" consisting of a designated area where dogs can have supervised play time.

- Q. *Why franchise?***

A. The primary benefit of franchising is risk minimization. It is a fact that starting a new business is risky. Franchising reduces that curve substantially. Franchising provides a cost efficient uniform system of operation. Another benefit to franchising is proven marketing. The franchisor can provide advice about how to develop effective marketing programs. A franchisor also provides training. This is especially important when dealing with a complex concept. The best training combines classroom or one-on-one training at the franchisor's facility with field training at the franchisee's place of business. Finally, franchising has found a solid economic niche that caters to specialized needs.

4. Q. **How much does a BNB Franchise Cost?**

A. The estimated total investment necessary to begin operation of a Bark 'N Bubbles franchise is \$114,600 to \$218,100 which includes a franchisee fee of \$35,000. The estimated total investment necessary to begin operation of a Bark 'N Bubbles franchise with "Social Puppy Pad" is \$116,100 to \$273,100 which includes a franchisee fee of \$35,000.

The initial investment varies depending on the region you build in, the size of your location, the condition of the premises, the amount of construction and your capabilities.

5. Q. *How size space do I need?*
- A. The franchised business typically requires between 800 to 2,000 square feet of space and is usually located near a main thoroughfare. The franchised business with "Social Puppy Pad" typically requires between 1,200 to 3,400 square feet of space and is usually located near a main thoroughfare.
6. Q. *What is the charge for continuing services?*
- A. The continuing services or "royalty fee", is 7% of your gross sales and is paid weekly. Of this weekly fee, 5% entitles you to use the "Bark 'N Bubbles Dog Wash" service mark, use of our distinctive system, marketing assistance, ongoing business development and counseling and other benefits that come with being a Bark 'N Bubbles Dog Wash franchisee. The remaining 2% goes directly toward the national cooperate advertising and development fund which directly benefits you.
7. Q. *What about advertising?*
- A. Building recognition of Bark 'N Bubbles name and reputation is an essential objective that benefits everyone. You will spend a minimum of \$2,000 on grand-opening advertising during the first three months of operations. You will also spend at least 2% of your gross sales per month on local advertising.

The On-the-job training at a Bark 'N Bubbles corporate facility will provide you with the opportunity to learn the business inside and out. As you prepare for your Grand Opening, you will receive on-site support as well as regular visits from the support staff thereafter.

We will provide you with an in-depth operations manual that contains all of your day-to-day procedures, store policies, and every other pertinent aspect of the Bark 'N Bubbles franchise. You will rely on this well organized tool, as you start out and in the years ahead!

Marketing Support

9. Q. ***What is the term of my franchise agreement?***
- A. The initial term is 5 years. You may renew for an additional four terms of five years each, providing you have complied with the provisions of the Franchise Agreement. After the end of the 25 year term, a new franchise agreement would be signed.
10. Q. ***What qualities must I possess to be considered for a franchise?***
- A. Opening a Bark 'N Bubbles franchise requires a strong personal commitment and active involvement. Some of the qualities we look for in a potential franchisee include a genuine love and care for pets, integrity, personal and financial qualifications, high level of energy, positive attitude, dedication and leadership abilities.
11. Q. ***What level of gross sales can I achieve?***
- A. There are strict regulations in the franchise industry limiting our ability to estimate profits or revenues. This is because actual results of individual franchises are based on factors that are not within our control. The amount of gross sales you can generate will vary from franchise to franchise, and is directly dependent on many factors including:
- the population of pet owners
 - economic climate in your territory
 - your ability to follow our proven blueprint for success
 - your general desire to work hard and succeed in your business
- However after consulting with a Bark 'N Bubbles representative and reviewing the Franchise Disclosure Document, you will have the opportunity to contact our existing franchisees regarding their experiences. At some point during the approval process we recommend that all prospective franchise partners make their own independent investigation to determine whether or not the franchise will be profitable.
